ORDER

WHEREAS Rupertsland Resources Co. Ltd.

("Rupertsland") applied July 22, 1982 for an Order of the Commission declaring the British Columbia Petroleum Corporation ("B.C.P.C.") a common purchaser of natural gas from the Willow Halfway "A" Pool; and

WHEREAS Rupertsland owns a well in the Willow Area which tested gas from the Halfway "A" formation, namely:

Rupertsland et al Willow b-88-A/94-H-2; and

WHEREAS Rupertsland alleges that it is suffering drainage of raw gas in the Willow Halfway "A" Pool.

NOW THEREFORE the Commission hereby orders as

follows:

1. The Application of Rupertsland will be heard on October 18, 1982 commencing at 9:30 a.m. local time, in the Hearing Room of the Commission on the 21st Floor, 1177 West Hastings Street, Vancouver, British Columbia.
