WHEREAS Dome Petroleum Limited ("Dome") applied September 3, 1982 for an Order of the Commission declaring the British Columbia Petroleum Corporation ("B.C.P.C.") a common purchaser of natural gas in the Fireweed Area, Dunlevy Formation from a Pool which is stratigraphically equivalent to the zone producing the wells located as follows:
