ORDER

WHEREAS Northland Utilities (B.C.) Limited ("Northland") applied May 24, 1988 to amend its filed Gas Tariff Rate Schedules for its Tumbler Ridge Division to incorporate an interim decrease in rates to all customers effective June 1, 1988; and

WHEREAS the District of Tumbler Ridge informed the Commission that the availability of the Townsite for a public hearing as set forth in Commission Order No. G-56-88 was inappropriate; and

WHEREAS the Commission has considered all of the above and has determined that the dates as set out in Commission Order No. G-56-88 shall be amended.

NOW THEREFORE the Commission orders as follows:

- 1. Clauses 2 through 6 inclusive, including Notice of Public Hearing as contained in Commission Order No. G-56-88 are rescinded.
- 2. A public hearing will be held commencing at 9:30 a.m. local time on Tuesday, July 26, 1988 at the Tumbler Ridge Inn, 275 Southgate, P.O. Box 99, Tumbler Ridge, B.C.

- 3. Northland will arrange for publication not later than Tuesday, June 26, 1988 of a Notice of Public Hearing, as per attached copy, in one issue of the Weekly Record, Peace River Block News and other local news publications and community bulletin boards as may properly provide adequate notice to the population of Tumbler Ridge.
- 4. Northland is to file with the Commission not later than Friday, June 24, 1988 any additional prepared testimony and supplemental material upon which it intends to rely.
- 5. Interested persons intending to participate in the public hearing should give written Notice of Intention to do so to the Commission Secretary, and to the Applicant, to be received not later than Thursday, June 30, 1988. Such Notice should state the nature of the interest in the proceeding.
- 6. Interested persons intending to file a written submission or to have questions of the Applicant should provide one copy to the Commission Secretary, and one copy to the Applicant not later than Thursday, June 30, 1988.

NOTICE OF PUBLIC HEARING

THE APPLICATION

Northland Utilities (B.C.) Limited ("Northland") applied May 24, 1988 to amend its filed Gas Tariff Rate Schedules at its Tumbler Ridge Division to incorporate a decrease in rates to all customers effective June 1, 1988.

By Commission Order No. G-59-88, the Commission has ordered a public hearing to review the Application which includes an interim decrease in rates, effective June 1, 1988.

THE PUBLIC HEARING

INTERVENTIONS

Any person wishing to be present at the public hearing and to give evidence or cross-examine witnesses should provide written notice, to be received not later than Thursday, June 30, 1988 to the Commission Secretary, and to the Applicant. The notice should include a brief statement as to the nature of the interest in the proceedings.

SUBMISSIONS BY INTERESTED PERSONS

Any person intending to file a written submission or to make a request for additional information of the Applicant should ensure that it is received not later than Thursday, June 30, 1988, one copy to the Commission Secretary, and one copy to the Applicant.
