ORDER

WHEREAS:

- A. On September 2, 1999 the Commission, by Order No. G-88-99, issued its Decision and Bypass Rate Guidelines for British Columbia Hydro and Power Authority ("B.C. Hydro"); and
- B. On November 13, 2001, the Commission received a B.C. Hydro Bypass Application from Canadian Forest Products Ltd. Upper Fraser Division ("Canfor Upper Fraser"); and
- C. On December 7, 2001, B.C. Hydro applied to the Commission for approval of a November 23, 2001 Special Electric Service Agreement for a Bypass Rate with Canfor Upper Fraser effective June 1, 2002, in accordance with the Bypass Rate Guidelines; and
- D. The Special Electric Service Agreement with Canfor Upper Fraser is identified as Tariff Supplement No. 60 and is to be in effect for a period of 20 years, from June 1, 2002 to May 31, 2022, and will be billed at the Bypass Rate of Rate Schedule 1821 plus a Rider Charge of \$5,775.25 per monthly billing that is equivalent to the customer's cost of bypass; and
- D. The Commission has reviewed the application and finds that it should be approved.

NOW THEREFORE the Commission approves for B.C. Hydro its November 23, 2001 Special Electric Service Agreement, Tariff Supplement No. 60 with Canfor Upper Fraser for a Bypass Rate at the equivalent of Rate Schedule 1821 plus a monthly rider of \$5,777.25 for a period of 20 years, effective June 1, 2002.
