ORDER

WHEREAS:

- A. On October 12, 2005 FortisBC Inc. ("FortisBC") applied (the "Application") to the Commission for a Certificate of Public Convenience and Necessity ("CPCN") for the Nk'Mip Transmission and Substation Project ("the Project"); and
- B. The Commission Panel, by Order No. G-114-05, ordered that an Oral Public Hearing be held to review the Application and set down a regulatory timetable and determined that no participant funding would be available for this hearing; and
- C. The Commission Panel issued a letter (Exhibit A-8) on December 22, 2005 describing the procedural format for the Oral Hearing; and
- D. The Commission Panel, by Letter No. L-01-06, varied Order No. G-114-05 to allow participants to apply for participant funding assistance; and
- E. The Commission Panel, by Order No. G-3-06, changed the format for the Oral Public Hearing scheduled for January 21, 2006 to a Pre-hearing Conference and Town Hall Meeting, and proposed an Issues List and a Revised Schedule for the hearing to review the Application; and

- F. At the January 21, 2006 Pre-hearing Conference, FortisBC, Mr. Hans Karow and Osoyoos Now suggested changes to the proposed Issues List and Regulatory Timetable; and
- G. The Commission Panel has determined that a Revised Regulatory Timetable for the review of the Application is required.

NOW THEREFORE the Commission orders as follows:

- 1. The Commission directs that the Oral Public Hearing for the review of the Application will commence at 9:00 a.m. on Monday, March 20, 2006 at the Osoyoos Seniors' Centre, 17 Park Place, Osoyoos, B.C., and establishes the Revised Regulatory Timetable for the proceeding that is attached as Appendix A to this Order.
- 2. The Issues List for the proceeding is attached as Appendix B to this Order.
