O R D E R

WHEREAS:

- A. BCTC filed on March 1, 2006, pursuant to sections 58 to 61 of the Utilities Commission Act, an application for approval of tariff terms and conditions related to the provision of Network Service ("the Application"); and
- B. The Commission Panel held a Procedural Conference on Wednesday, April 19, 2006, to address procedural matters related to the Application; and
- C. By letter dated April 20, 2006, the Commission Panel sought submissions from Intervenors and a reply submission from the Applicant on the appropriate scope of the proceeding prior to the Commission Panel issuing a procedural order setting out a process and timetable for reviewing the Application; and
- D. The Commission received submissions from Intervenors and a reply submission from BCTC and has issued a letter on the appropriate scope of the proceeding.

NOW THEREFORE the Commission orders as follows:

- 1. The Commission establishes a process to review the Application in accordance with the Regulatory Timetable attached as Appendix A to this Order.
