## ORDER

## WHEREAS:

- A. On August 23, 2007 Central Heat Distribution Limited ("CHDL") filed with the Commission, pursuant to Sections 58 and 61 of the Utilities Commission Act (the "Act"), an Application to increase its Steam Tariff Schedule of Charges by 10.51 percent effective October 1, 2007 on a permanent basis; and
- B. CHDL separately charges its customers for most of the energy input costs and when the requested increase in Steam Tariff rates is combined with the energy input costs, customers will receive an average increase of approximately 2.74 percent effective October 1, 2007; and
- C. The Application is the first rate change since January 2003 and seeks to recover increased operating, production and labour costs resulting in a revenue deficiency of approximately \$613,246 in 2007. The requested rate increase would allow the utility to earn a projected return on common equity in 2007 of 8.70 percent and 7.02 percent on rate base; and
- D. The Application contains a customer notice regarding the requested increase in steam charges that CHDL intends to send to all of its customers; and
- E. The Commission considers that a regulatory timetable should be established for review of the Application.
