O R D E R

WHEREAS:

- A. On February 15, 2008, Plateau Pipe Line Ltd. ("Plateau") applied to the Commission for approval of an increase in its Tariff Rate from \$2.30/m³ to \$6.08/m³ effective March 1, 2008 covering the gathering, transportation and delivery of crude oil and condensate by pipeline from established receiving points at Taylor, B.C. to Dawson Creek, B.C. (the "Application"); and
- B. Plateau advised the Commission that all Shippers on the Taylor to Dawson Creek Pipeline have been notified of the requested Tariff Rate increase. No comments or complaints have been received by the Commission regarding the Application; and
- C. The Commission has reviewed the Application and finds that approval is warranted.

NOW THEREFORE the Commission orders as follows:

- 1. Pursuant to Section 44 of the Pipeline Act, the Commission approves for Plateau the Application's requested increase in its Tariff Rate from \$2.30/m³ to \$6.08/m³ effective March 1, 2008 for the Taylor to Dawson Creek Pipeline.

2. The Tariff Rate increase is subject to review by the Commission in the event of a complaint by one or more Shippers on the pipeline within 60 days of this Order. If a complaint is received by the Commission after 60 days of this Order, any adjustments in the Tariff Rate will be on a prospective basis.
3. Plateau is to file an amended Tariff Rate Schedule in accordance with this Order in a timely manner.
4. Plateau is to deliver a copy of this Order to all Shippers on the pipeline.
