Re: Central Coast Power Corporation ("CCPC") and Boralex Ocean Falls Limited Partnership ("Boralex LP") Project No. 3698513/Order No. G-121-08 Application for Approval of the Sale and Disposition of Utility Assets of Central Coast Power Corporation to Boralex Ocean Falls Limited Partnership

On September 24, 2008 the Commission received the response of CCPC and Boralex LP to the Commission's Information Request No. 1 ("CCPC and Boralex LP Information Response"). Upon review of the CCPC and Boralex LP Information Response, the Commission determined that it needs to ask an Information Request No. 2.

On October 1, 2008 the Heiltsuk Tribal Council ("Heiltsuk") issued an Information Request to the Commission. By letter dated October 3, 2008, the Commission responded to the Heiltsuk's Information Request, advised the Heiltsuk to direct their questions to CCPC and Boralex LP and informed the Heiltsuk that the deadline for Intervenor Information requests and response would be extended.

In order to provide additional time for the issuance of Commission Information Request No. 2 and for the Heiltsuk to direct their questions to CCPC and Boralex LP, the Commission amends the regulatory timetable as follows:
