# IN THE MATTER OF the Utilities Commission Act, R.S.B.C. 1996, Chapter 473

and

An Application by Terasen Gas Inc. for Mist Storage Contracts and a Related Delivery Agreement

#### ORDER

### WHEREAS:

- A. On July 2, 2008 Terasen Gas Inc. ("Terasen Gas") filed with the Commission executed copies of letter agreements for Mist Storage and redelivery of gas related to Mist Storage. In addition, TGI filed an agreement to sublease Mist Storage to Terasen Gas (Vancouver) Island Inc. ("TGVI") and an associated delivery agreement; and
- B. The Commission has reviewed the Terasen Gas filing and is satisfied that the gas storage and delivery agreements should be accepted for filing.

**NOW THEREFORE** pursuant to Section 71 of the Utilities Commission Act and the Commission's Energy Supply Contract - Rules, the Commission accepts for filing the six contracts described as follows:

- 1. Mist Storage Agreement H with Northwest Natural Gas Company.
- 2. Mist Storage and Huntingdon Exchange Agreement between Shell Energy North America (Canada) Inc., Shell Energy North America (US), L.P. and Terasen Gas Inc. dated June 20, 2008.
- 3. Extension of Mist Storage and Huntingdon Exchange Agreement between IGI Resources, Inc. and TGI dated July 15, 2004 as amended.
- 4. Extension of Mist Storage and Huntingdon Exchange Agreement between IGI and TGI dated September 15, 2005 as amended.

- 5. Mist Storage Agreement between TGI and TGVI dated June 24, 2008.
- 6. Amendment to Agreement between TGI and TGVI with respect to Mist Storage dated June 14, 2004 as amended.
