WHEREAS:

- A. Pursuant to Section 71 of the Utilities Commission Act (the "Act") on September 5, 2008 British Columbia Hydro and Power Authority ("BC Hydro") filed with the Commission an agreement (the "Amending Agreement") that amends Electricity Purchase Agreements and which BC Hydro processed during period ending August 31, 2008 (the "Application"). The Amending Agreement is listed in Appendix A to this Order and are more specifically identified in Schedule A ("Schedule A") of the Application; and
- B. Included with the Application, BC Hydro submitted Schedule B, Summary of EPA Contractual Developments, that sets out contractual developments related to Electricity Purchase Agreements that BC Hydro considers are not amendments to the agreements, and which are listed in Appendix B to this Order, and
- D. The Commission has considered the Application, and has determined that it is in the public interest.
