ORDER

WHEREAS:

- A. Pursuant to section 71 of the *Utilities Commission Act* (the "Act") on February 5, 2009 British Columbia Hydro and Power Authority ("BC Hydro") filed with the British Columbia Utilities Commission (the "Commission") agreements (the "Amending Agreements") that amend Electricity Purchase Agreements and which BC Hydro processed during the period ending December 31, 2009 (the "Application"). The Amending Agreements are listed in Appendix A to this Order and are more specifically identified in Schedule A of the Application; and
- B. Included with the Application, BC Hydro submitted Schedule B, Summary of EPA Contractual Developments, that sets out contractual developments related to Electricity Purchase Agreements that BC Hydro considers are not amendments to the agreements, and which are listed in Appendix B to this Order; and
