O R D E R

WHEREAS:

- A. On June 16, 2008, the British Columbia Utilities Commission ("Commission") by Letter L-27-08, accepted the Terasen Gas Inc. ("Terasen Gas") 2008/09 Midstream Annual Contracting Plan; and
- B. On November 20, 2008, the Commission by Order No. E-22-08, accepted Terasen Gas' filing of gas supply contracts for the period November 1, 2008 to October 31 2009; and
- C. On March 19, 2009, Terasen Gas filed with the Commission for acceptance the monthly and daily market premiums for the remainder of the commodity baseload transactions for the period April 1, 2009 to October 31, 2009; and
- D. The Commission has reviewed the Terasen Gas filing and is satisfied that the gas supply contracts are consistent with the 2008/09 Midstream Annual Contracting Plan and are appropriate considering market prices at the time the contracts were negotiated.

NOW THEREFORE the Commission accepts for filing pursuant to section 71 of the of the Utilities Commission Act and the Commission's Rules for Natural Gas Energy Supply Contracts, the March 19, 2009 Terasen Gas filing of natural gas supply contracts identified in Appendix A (attached) for the period April 1, 2009 to October 31, 2009.
