O R D E R

WHEREAS:

- A. By Order G-111-09 the British Columbia Utilities Commission ("Commission") established a timetable for Regional Sessions open to all Participants and the public to discuss issues related to regional transmission needs in relation to the Inquiry, including potential generation resources and anticipated regional electricity demand; and
- B. On September 21, 2009, the Commission received a letter from the We Wai Kai Nation (Cape Mudge Indian Band) requesting that Nanaimo Regional Session be rescheduled to avoid a conflict with a First Nations Summit Meeting in Vancouver scheduled for the period of November 25-27, 2009; and
- C. The Commission has considered the We Wai Kai Nation's request and determined that the Nanaimo Regional Session should be rescheduled.

NOW THEREFORE the Commission orders as follows:

- 1. Paragraph 1 of Order G-111-09 is varied to the extent that the Nanaimo Regional Session is rescheduled to take place on Tuesday, December 1, 2009.
- 2. Details on the specific location and timing of the Nanaimo Regional Session will be released after British Columbia Hydro and Power Authority, British Columbia Transmission Corporation and FortisBC Inc. have filed their preliminary evidence.
- 3. A revised Regional Session schedule is attached as Appendix A to this Order.
