Pursuant to Appendix B to Order G-83-09, the Commission scheduled a Procedural Conference for Thursday, August 6, 2009 at 9:00 a.m. for further review of the ILM Reconsideration proceeding. The Commission received a request from BC Hydro to consider re-scheduling the Procedural Conference from Thursday, August 6, 2009 to Thursday, August 13, 2009 (Exhibit C3-6). The Commission also received a letter from BCTC that requested to re-schedule the August 6, 2009 Procedural Conference to sometime in the week of August 25th (Exhibit B-8).

On July 31, 2009 the Commission cancelled the August 6, 2009 Procedural Conference and sought comments from participants for their availability from August 24th to August 28th for the re-scheduled Procedural Conference.

After considering the comments received from participants, the Commission Panel re-schedules the August 6, 2009 Procedural Conference to Friday, August 28, 2009. The Revised Regulatory Timetable is set out in Appendix A to this Letter, including tentative dates for Intervenor Evidence, Information Requests, and Responses.
