ORDER

WHEREAS:

- A. On August 5, 2009, British Columbia Hydro and Power Authority ("BC Hydro") filed with the Commission an Application for acceptance, pursuant to Section 44.2(1)(b) of the Utilities Commission Act (the "Act"), that capital expenditures BC Hydro anticipates making in respect of the Gordon M. Shrum ("GMS") Units 1 to 5 Turbine Replacement Project (the "Project") are in the public interest; and
- B. BC Hydro applied for acceptance of the capital expenditures in the schedule pursuant to section 44.2(3)(a) of the UCA, rather than for approval of a Certificate of Public Convenience and Necessity ("CPCN") under sections 45 and 46 of the Act, but states that the Application has been structured to comply with the Commission's current CPCN Application Guidelines; and
- C. In the capital plan submitted as part of the F2009 and F2010 Revenue Requirements Application ("F09/F10 RRA") BC Hydro forecasted it would incur capital expenditures of \$6.4 million to the end of F2010 in respect of the Project and estimated that the cost for the Project would fall within a range of cost of \$170 million to \$240 million; and
- D. Since the F09/F10 RRA, the Project was updated to reflect the results of analysis of the GMS Unit 3 failure and the Project Expected Cost is now \$262 million and the Authorized Cost is \$319 million, and the first Unit will be in service November 2010 and the entire Project is expected to be complete by March 2017; and
- E. The primary justification for the Project is the unsatisfactory condition of the GMS Units 1 to 5 turbines and the associated high business risks; and

- F. The Project involves replacing the Units 1 to 5 turbines. Specifically, this will include designing and manufacturing new turbine runners, wicket gates, wicket gate operating mechanisms and head covers and overhauling the remaining turbine components; and
- G. BC Hydro proposes to hold a Workshop on the Mica GIS Project and the Gordon M. Shrum Units 1 to 5 Turbine Replacement Project in the Commission Hearing Room on the Twelfth Floor, 1125 Howe Street, Vancouver, BC on Wednesday, August 26, 2009 commencing at 9:00 a.m.; and
- H. The Commission considers that a written public hearing is required for the regulatory review of the Application.

NOW THEREFORE the Commission orders as follows:

- 1. The Commission establishes a written public hearing process for the review of the Application according to the Regulatory Timetable set out in Appendix A to this Order.
- 2. BC Hydro will publish, as soon as possible, in display-ad format, the Notice attached as Appendix B to this Order, in the Vancouver Sun, the Province, the Victoria Times Colonist and such other appropriate localnews publications as may properly provide adequate notice to residents in the vicinity of the Project.
- 3. BC Hydro will provide a copy of the Application and this Order to any potentially affected First Nation and Tribal Councils.
- 4. The Application, together with any supporting materials, will be made available for inspection at the BC Hydro offices at 333 Dunsmuir Street, Vancouver, BC, V6B 5R3 and at the British Columbia Utilities Commission, Sixth Floor, 900 Howe Street, Vancouver, BC, V6Z 2N3 and will also be available on the BC Hydro website.
- 5. Intervenors or Interested Parties should register with the Commission in writing or by electronic submission by Thursday, September 3, 2009. Intervenors should specifically state the nature of their interest in the Application and identify generally the nature of the issues that they may intend to pursue during the proceeding and the nature and extent of their anticipated involvement in the review process.

NOTICE OF APPLICATION AND WRITTEN PUBLIC HEARING

THE APPLICATION

On August 5, 2009, British Columbia Hydro and Power Authority ("BC Hydro") filed with the Commission an Application for acceptance, pursuant to Section 44.2(1)(b) of the Utilities Commission Act (the "Act"), that capital expenditures BC Hydro anticipates making in respect of the GMS Units 1 to 5 Turbine Replacement Project (the "Project") are in the public interest.

The Project, located on the Peace River near Hudson's Hope in North Eastern British Columbia, involves replacing Units 1 to 5 turbines. Specifically, this will include designing and manufacturing new turbine runners, wicket gates, wicket gate operating mechanisms and head covers and overhauling the remaining turbine components. The Project has an Expected Cost and an Authorized Cost of \$262 million and \$319 million respectively, and the expected in-service date is March 2017.

THE REGULATORY PROCESS

Order No. G-94-09 established the Regulatory Timetable for the review of the Application by way of a Written Public Hearing.
