ORDER

WHEREAS:

- A. On June 30, 2011, Fortis BC Inc. (Fortis BC or the Company) filed with the British Columbia Utilities Commission (Commission) an application for approval of its 2012 2013 Revenue Requirements and the review of its 2012 Integrated System Plan (collectively referred to as the Application);
- B. In accordance with Order G-111-11, two rounds of Commission and Intervener Information Requests (IR) were issued to FortisBC on August 10 and on September 30, 2011. FortisBC responded to IR No.1 on September 9 and will respond to IR No. 2 on October 21, 2011;
- C. FortisBC proposed that the Application proceed through a negotiated settlement process, or alternatively, by way of a written hearing process;
- D. According to the terms of the Company's Performance-Based Regulation Plan for 2011, an Annual Review is required to assess the Company's forecast 2011 financial results and non-financial performance;
- E. The Commission considers establishing a date for a Procedural Conference and setting a formal process to review intervener evidence is necessary and in the public interest. Other procedural items are also established in Appendix A to this Order.

NOW THEREFORE the Commission orders as follows:

1. A Revised Preliminary Regulatory Timetable for this Application is set out in Appendix A to this Order. If a negotiated settlement process is established, it may proceed as early as December 7, 2011. If this Application proceeds by way of a written or oral hearing, these dates will be set subject to a further Order establishing the review process.
