O R D E R

WHEREAS:

- A. Section 125.2 of the *Utilities Commission Act* (Act) assigns exclusive jurisdiction to the British Columbia Utilities Commission (Commission) to determine whether a "reliability standard," as defined in the Act, is in the public interest and should be adopted in British Columbia. By Order G-123-09, the Commission approved the Compliance Monitoring Program (CMP) for monitoring and enforcement of adopted reliability standards and appointed the Western Electricity Coordinating Council (WECC) as its Administrator for registration and monitoring compliance as per section 8 of the Act;
- B. Commission Order G-67-09 requires entities subject to approved Mandatory Reliability Standards to file mitigation plans outlining how they plan to achieve compliance;
- C. Pursuant to Section 5.3 of the CMP, a Mitigation Plan with respect to an Alleged Violation may be submitted at any time, and a Mitigation Plan with respect to a Confirmed Violation must be submitted within ten business days following confirmation by the Commission;
- D. On October 18, 2012, Dokie General Partnership (Dokie) submitted a Mitigation Plan to address the Alleged Violation of Reliability Standard PER-002-0 R3. The proposed completion date for the Mitigation Plan was December 19, 2012;
- E. By letter dated October 31, 2012, WECC recommended acceptance of the following Mitigation Plan to bring Dokie into compliance with the standard identified below:

- F. On December 14, 2012, and January 12, 2013, Dokie submitted two Extension Requests for the Mitigation Plan addressing the Alleged Violation of Reliability Standard PER-002-0 R3. The requested completion dates were January 18, 2013 and February 22, 2013 respectively;
- G. By letter dated February 7, 2013, WECC recommended acceptance of the Extension Request identifying a completion date as follows:

- H. The Commission has reviewed WECC's recommendation and considers approval of the Mitigation Plan with the February 22, 2013 completion date is warranted.

NOW THEREFORE pursuant to section 125.2 (10) of the Act and in accordance with the Compliance Monitoring Program, the Commission accepts WECC's recommendation and approves the Mitigation Plan with completion date as identified in recital G above.
