ORDER

WHEREAS:

- A. On July 23, 2021, British Columbia Hydro and Power Authority (BC Hydro) filed an application with the British Columbia Utilities Commission (BCUC) for a Certificate of Public Convenience and Necessity (CPCN) pursuant to sections 45 and 46 of the *Utilities Commission Act* (UCA) for the Bridge River 1 Units 1 to 4 Generator Replacement Project (BR1 Project) and a CPCN for the Bridge River Transmission Project (BRT Project) (together, Application);
- B. In the Application, BC Hydro requests approval for:
 - a. The BR1 Project to replace aging generating equipment within the Bridge River 1 Generating Station; and
 - b. The BRT Project to increase the maximum capacity of the 2L90 circuit and to refurbish existing circuit infrastructure;
- C. In the Application, BC Hydro requests that certain information in the Application and several Appendices be held confidential due to the commercially sensitive nature of the information, in accordance with Part IV of the BCUC's Rules of Practice and Procedure; and
- D. The BCUC has commenced its review of the Application and determines that the establishment of a public hearing and a regulatory timetable are warranted.

Regulatory timetable 1 of 2

NOW THEREFORE the BCUC orders as follows:

- 1. A public hearing is established for the review of the Application in accordance with the regulatory timetable as set out in Appendix A to this order.
- 2. BC Hydro must publish the Public Notice, attached as Appendix B to this order, in print/display-ad format in appropriate news publications, such as but not limited to, local and community newspapers to provide adequate notice to those parties who may have an interest in or be affected by the Application, as soon as reasonably possible, but no later than Tuesday, September 14, 2021.
- 3. As soon as practicable, but not later than Tuesday, September 14, 2021, BC Hydro must publish notice of this Application on its website and social media platforms. It must also publish weekly reminder notices on each platform until the conclusion of the intervener registration period on Tuesday, September 28, 2021.
- 4. BC Hydro must provide an electronic copy of the Application and this order by no later than Tuesday, September 14, 2021 to registered interveners in the BC Hydro 2022 Revenue Requirements proceeding and potentially affected Indigenous groups.
- 5. Persons who wish to actively participate in this proceeding must complete a <u>Request to Intervene Form</u>, available on the BCUC's website at https://www.bcuc.com/get-involved/get-involved-proceeding.html by Tuesday, September 28, 2021 as established in the regulatory timetable attached as Appendix A to this order, and in accordance with the <u>BCUC's Rules of Practice and Procedure</u>.
- 6. The BCUC accepts BC Hydro's confidentiality requests, as filed, unless determined otherwise by the BCUC.

British Columbia Hydro and Power Authority Application for Certificates of Public Convenience and Necessity for the Bridge River Projects

On July 23, 2021, BC Hydro and Power Authority filed a joint Application for Certificates of Public Convenience and Necessity for the Bridge River 1 Units 1 to 4 Replacement Project and the Bridge River Transmission Project (Application). The purpose of the Bridge River 1 Project is to address the deteriorating condition of the aging generators, governors, exciters and control systems at the Bridge River 1 Generating Station, both to improve reliability and to improve water flow management in Lower Bridge River to help avoid negative impacts to fish and fish habitat and St'át'imc Nation values. The expected cost of the Bridge River 1 Project is \$326.3 million including all contingencies, inflation, capital overhead, interest during construction and reserves. The purpose of the Bridge River Transmission Project is to address system constraints on the Bridge River Transmission System to accommodate existing and future generation, and to address asset health issues and clearance defects to improve the reliability and safety of the 2L90 circuit. The conceptual expected cost of the Bridge River Transmission Project is \$66.2 million at an AACE Class 5 estimate.
