## **ORDER**

## **WHEREAS:**

- A. On September 17, 2024, FortisBC Energy Inc. (FEI) applied to the British Columbia Utilities Commission (BCUC) pursuant to section 18 of the BCUC's Rules of Practice and Procedure and section 71(5) of the *Utilities Commission Act* (UCA) to request that certain information relating to the following filings be held confidential by the BCUC (Confidentiality Request):
  - i. FEI's Application to Implement the RNG Blend Service, Storage and Transportation RNG Rider, and Changes to the RNG Charge (RNG Blend and RNG Charges Application); and
  - ii. FEI's Compliance Filing and Application for Approval of Tariff Amendments (Tariff Application);
- B. By Order G-237-24 dated August 29, 2024, the BCUC issued its decision regarding the Tariff Application. The BCUC did not make any directives regarding confidentiality in Order G-237-24;
- C. By Order G-242-24 dated September 11, 2024, the BCUC issued its decision regarding the RNG Blend and RNG Charges Application and ordered that the information in Appendix B of that application be held confidential as it contains commercially sensitive information;
- D. In the Confidentiality Request, FEI states that certain additional information should be kept confidential in the RNG Blend and RNG Charges Application, as well as in the related BCUC Staff Questions dated June 27, 2024, and FEI's Responses to BCUC Staff Questions dated July 15, 2024, related to FEI's RNG supply acquisition volume, price, and mitigation revenue;
- E. In the Confidentiality Request, FEI further states that FEI's Responses to BCUC Staff Questions dated July 29, 2024, in relation to the review of the Tariff Application, make references to confidential information;
- F. Between September 13 and 17, 2024, FEI provided redacted versions of the following documents:
  - The RNG Blend and RNG Charges Application, as well as the related BCUC Staff Questions and FEI's Responses to BCUC Staff Questions; and

- ii. FEI's Responses to BCUC Staff Questions related to the Tariff Application.
- G. The BCUC has reviewed the Confidentiality Request and considers that the following determinations are warranted.

**NOW THEREFORE** the BCUC orders that the unredacted versions of the following documents will be held confidential until the BCUC determines otherwise:

- a. The RNG Blend and RNG Charges Application, as well as the related BCUC Staff Questions and FEI's Responses to BCUC Staff Questions; and
- b. FEI's Responses to BCUC Staff Questions related to the Tariff Application.
